- ❖ Budget Hearing
  - Budget modifications of the 2020-2021 Special Education Fund, the General Education Fund, Vocational Education Fund were approved.
  - 2021-2022 General Education Fund, Special Education and Vocational Education Fund were approved.
  - The Board Certified the 2021 General Education Levy of .1974 mills, Special Education Levy of 2.5915 mills and Vocational Education Levy of .9873 mills.
